I was involved in hiring minute takes, to now doing the minutes myself. One must have an understanding of what to capture on paper for the minutes. Experience is the key to success in minute taking for CSU52. I have assisted the office operation in the acting role when called upon while the President and First Vice President were unavailable.

I have also sat on many committees from Bylaws and Constitution, Discipline, Social Committee to Policy and Procedures, Hiring and most recent Public Relations and Members and Community Support Committee.
